- ✓ SUBMISSIONS should be made electronically to grp-ftbl-internationalconference@ugd.edu.mk. **Each participant may submit a maximum of two papers - one as the first author, the other as co-author. There may not be more than 3 authors per paper.**
- ✓ The papers could be in MACEDONIAN or ENGLISH.
- ✓ All manuscript should be in Microsoft Word file (*.doc or *.docx).
- ✓ Papers should be no less than 9 pages, or more than 20 pages and they should be technically adjusted to the propositions as to the given template. Papers may extend the limit if seen as needed to get a clear definition of the problem that is addressed.

IMPORTANT DATES

April 1, 2022 – Deadline for full paper submission.

April 10, 2022 – Notification for accepted manuscript.

The papers will be fully refereed, and the final decision will be based on the full paper. After that authors will be notified by email.
